4. FIRST-AID MEASURES

* Inorganic tin salts are poorly absorbed into the body. When parenterally administered tin salts are highly toxic. Tin oxide inhaled as a dust or fume leads to a benign pneumoconiosis with no sign of interference with pulmonary function. Deposited dust appears nodular with the particles being mostly extracellular. No necrosis, foreign-body giant-cell reaction, or collagen formation has been seen. Tin salts that have gained access to the blood stream are highly toxic and produce neurologic damage and paralysis. With most common tin salts, the toxicity profile is complicated by hydrolysis in body fluids producing unphysiologic pH values.
